



CLUB BYLAWS

As of March 9, 2020

BYLAW 1: NAME

The Name of this Club shall be: AMS Bible Club at UBC

BYLAW 2: PURPOSE

The Purpose(s) of this organization shall be:

1. To analyze and interpret the Bible literally, historically, grammatically, and contextually.
2. To develop a clear understanding of Biblical principles and learn how these can apply to each individual in our modern society.
3. To encourage and strengthen students during their time at university through exhortation based on the Bible's promises.

As stated in Article 3.3 of the Club Master Constitution, "The club must designate a category for itself in its bylaws". Our club is categorized as: Spiritual.

BYLAW 3: EXECUTIVES

The Executives of the Club shall be elected annually and shall be as follows

1. President
2. Treasurer

The number of executives of the club shall be as few or many as required. As of Spring 2020, the club will only have two executive members but will increase as the need arises.

BYLAW 4: EXECUTIVE DUTIES

President

Act as liaison to SAC

To call for a General Meeting each fall and spring term and act as the Chair

Act as one of two Booking Representatives

Host and run weekly Bible Club Meetings

Organize and oversee Group Bible studies

Overseeing the Events Committee

Treasurer

Act as liaison to Finance Commission
Act as one of two Booking Representatives
Act as the sole signing officer
Overseeing weekly online newsletters
Overseeing the Food Committee

BYLAW 5: MEMBERSHIP FEES

- 5.1 Active membership fees shall be (minimum \$1): \$10
- 5.2 Associate membership fees shall be at least fifty percent (50%) more than the Active membership fees (minimum \$1.50): \$15
- 5.3 Membership fee is paid once annually and is non-refundable
- 5.4 Membership fees cover cost of student curriculum and help subsidize cost for food

BYLAW 6: MEMBERSHIP PRIVILEGES/RESPONSIBILITIES

- 6.1 Only Active AMS members shall be eligible to vote, sign Petitions, or be elected.
- 6.2 Active and Associate AMS members will have access to office space (by discretion of Executive members) and study rooms booked by the club
- 6.3 Active and Associate members will receive Bible study curriculum and a Bible, if desired
- 6.4 Active and Associate members will have access to the small library of Christian books/resources
- 6.5 Annually, all members must:
 - pay the membership fee
 - fill out the Club Application Form
 - sign the AMS General Waiver Form

BYLAW 7: STANDING COMMITTEES

The Club shall have the following Standing Committees:

- 1. Food Committee
- 2. Events Committee

BYLAW 8: COMMITTEE DUTIES

The duties of the Standing Committees shall be as follows:

- 1. The Food Committee shall be in charge of the weekly provision of food for Bible club meetings. The committee may get money reimbursed, upon discretion of the club treasurer.
- 2. The Events Committee shall be in charge of executing and organizing the monthly outings for the club. This includes, but is not limited to, the sufficient advertising of the outing, the organizing of rides to the specified location, and ensuring any supplies that are needed are brought.
